The Amalgamated Carpenters and Joiners Union (Painters) have NO interest and NO plans to support our retired members.

Public Work: Municipal work under the PLA's and work that mandates certified apprenticeship programs will continue to be done by Local 1556 and other affiliated UBC Locals.

Private Work: A majority of the Private Sector Market is done by General Contractors that are signatory with the UBC and will only contract to contractors that are signed with the UBC.

SO MANY UNANSWERED QUESTIONS

Consider Asking These Questions...

- 1. Ask for signed copies of current contracts with contractors. What employees do they represent?
- 2. How many actual members (Dockbuilders) have Amalgamated union cards? Can we see one?
- 3. Names of President and Executive Board? Who will appoint the Executive Board?
- 4. Who are the Benefit Fund Trustees? How will Amalgamated support retired Dockbuilders?
- 5. Location of Union Hall? Location of Training Center?
- 6. If a member joins Amalgamated, will he be able to continue working for contractors who remain signatory with the N.Y.C.D.C.C.?
- 7. Where specifically will the 20-30% reduction in labor costs come from? Wages and Benefits?
- 8. Why are the Painters offering 401k's for the new members when defined pension plans are much more preferred and secure?*
- Will Construction Managers and General Contractors that are signatory with the N.Y.C.D.C.C. be obligated to sub-contract to contractors that are signatory with the N.Y.C.D.C.C.?
- 10. Was The Amalgamated Carpenter Union created to compete with the N.Y.C.D.C.C. by lowering wages and benefits for its members?
- 11. How many non-union companies has Amalgamated organized?
- 12. The Painters in New York have a 3% Dues Check-Off. Will Amalgamated have a 3% Dues Check-Off?
- 13. Have you discussed these questions with your family? Is your family aware of the risks of joining the Painter's Union? Do they know that they would suffer because of your decision to join the Painter's Union?

Please consider that the Amalgamated Painter's Union currently has NO ANSWERS to these questions.

IN SUMMARY...

By joining the Amalgamated (Painter's) Union you will be hurting OUR retirees and severely limit your ability to provide for yourself and your family. NO Municipal work, NO Plant work, NO State work and NO Private work that involves CM's or GC's that are signatory with the UBC.
